## **Policy Statement**

We (B+A Ltd) recognise that when you choose to provide us with information about yourself or your organisation, you trust us to act in a responsible manner. We believe this information should only be used to help us provide you with a quality service.

This Privacy Policy (together with terms and conditions and any other documents referred to in it) sets out the basis upon which any personal information we collect from you, or that you provide to us, will be processed by us.

## How we collect your personal information

Through the operation of our website, including any 'cookies' that are active, we may collect and process the following information about you:

- details of your visits to the website, including but not limited to, location data, traffic data and other communication data and the resources that you access;
- information that you provide by filling in forms on our website;
- information provided if/when you report a problem with our website; and
- information provided when you contact us through our website, or information collected by us through your emails or any other communications with us, however it is made.

We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.

When you provide personal information to us, or we collect personal information from other sources, we will treat that information in accordance with this Privacy Policy.

## Healthcare Data

B+A Limited is a Data Processor for personal healthcare data supplied by and processed on behalf of our clients, with whom we have a contract of engagement.

UK General Data Protection Regulation (UK:GDPR) Article 6, paragraph 1 (f) processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child;

GDPR Article 9, paragraph 2 (i) processing is necessary for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes in accordance with Article 89(1) based on Union or Member State law which shall be proportionate to the aim pursued, respect the essence of the right to data protection and provide for suitable and specific measures to safeguard the fundamental rights and the interests of the data subject.

# **Legitimate Interests**

B+A Limited has carried out a 'legitimate interest' assessment which concludes:

The processing of information relating to individuals who have had interactions with healthcare providers, including but not restricted to, hospitals and GP services, is required to achieve its 'legitimate interest' in providing consultancy services to healthcare providers.

This consultancy service will aim to improve decision-making around the provisioner-provision of existing and future healthcare infrastructure and service requirements; and that the nature of the data being processed, and the purposes for which it is being used, are considered to be low risk.

Any small risks will be mitigated by appropriate safeguards and controls.

## How we use your information

The information that we receive, collect or store relating to you is primarily used to enable us to provide our consultancy services to you. We may also use personal information provided by you, or gathered by us, for the following purposes:

- to provide any services and related products requested by you;
- to recommend services, and related products, that we believe will be of benefit/interest to you;
- to provide information on our activities, and those of our partner organisations, such as promotional materials and general updates relevant to you;
- to carry out duties and obligations arising from any contracts entered into between B+A Ltd and yourselves;
- to notify you about changes to our services, products or website;
- to process and respond to any specific information you may request;
- to respond to any enquiries or complaints received from you;
- to update our records;
- to process payments;
- to facilitate audit purposes;
- to prevent or detect fraud; and
- to enable third parties to carry out any of the purposes above on our behalf

## How we use healthcare data/information

## Storing your information

Data/information will only be stored for the purposes for which it was provided; When we have finished using your data, and any project-related activities have been concluded, we will remove your data from our systems, in line with statutory/audit requirements.

#### **Disclosing your information**

We may share your personal information with third parties in the following ways;

- we will release your personal information when we are required to do so for legal or regulatory purposes or as part of legal proceedings;
- we may share information you have provided with supply chain partners/sub-contractors if it is deemed necessary to fulfil our contractual obligations to you; and
- we may disclose your personal information to any member of our company.

We will not pass your information to third parties for marketing purposes if you have indicated that you do not want us to do this at the point where you submit your information on our website.

We will ask for confirmation of identity before we disclose any personal information to you.

If the quantity of information requested is significant, we reserve the right to charge a fee. Any such fee will be advised ahead of the request being carried out.
